Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mr. Donato of Medford in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

### *Messages from the Governor.*

A message from His Excellency the Governor recommending legislation relative to providing for the terms of certain bonds issued by the Commonwealth (House, No. 4092), was filed in the office of the Clerk on Friday, December 22. Bonds,—

The message was read; and it was referred, under Rule 17G, with the accompanying draft of a bill, to the committee on Bonding, Capital Expenditures and State Assets.

A message from His Excellency the Governor recommending legislation relative to ensuring compliance with federal standards regarding the handling of federal tax information (House, No. 4093), was filed in the office of the Clerk on Friday, December 22. Federal standards,—

The message was read; and it was referred, under Rule 30, with the accompanying draft of a bill, to the committee on State Administration and Regulatory Oversight. Sent to the Senate for concurrence.

### *Monthly Report.*

### *Petition.*

Mr. Dooley of Norfolk presented a petition (subject to Joint Rule 12) of Shawn Dooley relative to the definition of consistent with local needs under the affordable housing law; and the same was referred, under Rule 24, to the committee on Rules. Affordable

### *Papers from the Senate.*

The House Bill further regulating the administration of the oath of office of members of the city council and the school committee in the city of Malden (House, No. 4076) (its title having been changed by the Senate committee on Bills in the Third Reading), came from the Senate passed to be engrossed, in concurrence, with an amendment in section 1, in lines 13 and 14, striking out the following "the city council may choose an alternate date to fall within the first 8 days of the year" and Malden,—

inserting in place thereof the words “, the oath required shall be administered on the first Tuesday of that year”. The amendment was referred, under Rule 35, to the committee on Bills in the Third Reading. Said committee then reported that the amendment was correctly drawn; and it was adopted, in concurrence.

Establishing a sick leave bank for Elizabeth O'Brien, an employee of the Department of the Attorney General (Senate, No. 2176, amended in line 6 by striking out the words “department paid” and inserting in place thereof the words “extended illness”; and inserting before the enacting clause the following emergency preamble:

“Whereas, The deferred operation of this act would tend to defeat its purpose, which is to establish forthwith a sick leave bank for a certain employee of the department of the attorney general, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience.”) (on a petition);

Severally passed to be engrossed by the Senate, were read; and they were referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Reports of Committees.

By Mr. Murphy of Weymouth, for the committee on Steering, Policy and Scheduling, that the House Bill to preserve the competitiveness of group auto insurance plans (House, No. 4081), be scheduled for consideration by the House.

Under suspension of Rule 7A, on motion of Mr. Wong of Saugus, the bill was read a second time forthwith; and it was ordered to a third reading.

Subsequently, under suspension of the rules, on motion of the same member, the bill (having been reported by the committee on Bills in the Third Reading to be correctly drawn) was read a third time; and it was passed to be engrossed, its title having been changed by said committee to read: “An Act preserving the competitiveness of group auto insurance plans.”. Sent to the Senate for concurrence.

Emergency Measures.

The engrossed Bill establishing a sick leave bank for Jason Wendover, an employee of the Department of Correction (see Senate, No. 2082, amended), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 2 to 0. Sent to the Senate for concurrence.

Subsequently, the Senate having concurred in adoption of the emergency preamble, the bill (which originated in the Senate) was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.

The engrossed Bill establishing a sick leave bank for James McGonagle, an employee of the State Lottery Commission (see House, No. 4060, amended), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 2 to 0. Sent to the Senate for concurrence.

Subsequently, the Senate having concurred in adoption of the emergency preamble, the bill (which originated in the House) was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.
