Tomorrow, December 29th, marks the anniversary of the 1752 birth of Nathan Dane, a lawyer from Ipswich who was a member of this House from 1782 until his selection as a delegate to the Continental Congress in 1785. There he helped draft the Northwest Ordinance which secured the land north of the Ohio River for the United States. Wisconsin's capital, Madison, is situated in Dane County.

Nathan Dane was also known for his eight volume work on American law. He used the proceeds of this work to donate funds to Harvard Law School. For a while the school was called the Dane Law School. His name is engraved on the frieze of this Chamber. May God continue to bless our Commonwealth.
