JOURNAL OF THE HOUSE.

Monday, December 21, 2020.

Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mr. Donato of Medford in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

At the request of the Chair (Mr. Donato), the members and employees joined with him in reciting the pledge of allegiance to the flag.

Messages from the Governor.

A message from His Excellency the Governor returning with recommendation of amendment the engrossed Bill authorizing the town of Nantucket to supply itself and its inhabitants with water [see House, No. 4399] (for message, see House, No. 5205), was filed in the office of the Clerk on Friday, December 18.

Nantucket,—water supply.

The message was read; and, under the provisions of Article LVI of the Amendments to the Constitution, the bill was thereupon "before the General Court and subject to amendment and re-enactment".

Pending the question on adoption of the amendment recommended by His Excellency, the bill was referred, on motion of Mr. Speliotis of Danvers, to the committee on Bills in the Third Reading.

A message from His Excellency the Governor recommending legislation relative financing a program for improvements to the Unemployment Insurance Trust Fund and relief to employers in the Commonwealth (House, No. 5206), was filed in the office of the Clerk on Friday, December 18.

Unemployment insurance.

The message was read; and it was referred, under Rule 30, with the accompanying draft of a bill, to the committee on Labor and Workforce Development. Sent to the Senate for concurrence.

A message from His Excellency the Governor (under Section 8 of Article LXXXIX of the Amendments to the Constitution) recommending legislation relative to authorizing the town of Berlin to continue the employment of Paul Kenneth Clark (House, No. 5207), was filed in the office of the Clerk on Friday, December 18.

The message was read; and it was referred, under Rule 30, with the accompanying draft of a bill, to the committee on Public Service. Sent to the Senate for concurrence.

Pending the question on passing the bill to be engrossed, Mr. Speliotis of Danvers moved to amend it in line 6 by striking out the word "department" and inserting in place thereof the words "Massachusetts Department of Transportation".

Pending the question on passing the bill to be engrossed, Mr. Speliotis of Danvers moved to amend it in line 6 by striking out the word "department" and inserting in place thereof the words "Massachusetts Department of Transportation".

The amendment was adopted; and the bill (House, No. 4868, amended) was passed to be engrossed. Sent to the Senate for concurrence.
