### JOURNAL OF THE HOUSE.

Tuesday, May 31, 2022.

Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mr. Donato of Medford in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

At the request of the Chair (Mr. Donato), the members, guests and employees joined with him in reciting the pledge of allegiance to the flag.

#### Message from the Governor – Veto.

A message from His Excellency the Governor returning with his objections thereto in writing the engrossed Bill relative to work and family mobility [see House, No. 4805] (for message, see House, No. 4822), was filed in the Office of the Clerk on Friday, May 27.

The message was read; and, under House Rule 12, it was placed in the Orders of the Day for the next session, the question being on passing said bill, notwithstanding the said objections.

#### Message from the Governor.

A message from His Excellency the Governor (under Section 8 of Article LXXXIX of the Amendments to the Constitution) recommending legislation relative to certain voting precincts in the town of Middleton (House, No. 4823), was filed in the office of the Clerk on Friday, May 27.

The message was read; and it was referred, under Rule 30, with the accompanying draft of a bill, to the committee on Election Laws. Sent to the Senate for concurrence.

#### Guests of the House.

During the session, the Chair (Mr. Donato of Medford), declared a brief recess, and introduced, students from Framingham High School, who were seated in the House Chamber. #### Reports of Committees.

Under Rule 42, the report was considered forthwith; and it was accepted. Sent to the Senate for concurrence.

By Mr. Honan of Boston, for the committee on Steering, Policy and Scheduling, that the following House bills be scheduled for consideration by the House:

By Mr. Murphy of Weymouth, for the committee on Financial Services, on a petition, a Bill relative to telehealth and digital equity for patients (House, No. 1101). Referred, under Joint Rule 1E, to the committee on Health Care Financing.

By Mr. Chan of Quincy, for the committee on Consumer Protection and Professional Licensure, on Senate, No. 2535, reported, in part (on sections 17 to 23, inclusive, and 28) a Bill to extend live horse racing and simulcasting in the Commonwealth (House, No. 4817). #### Emergency Measure.

The engrossed Bill relative to certain retired employees during the outbreak of the 2019 novel coronavirus (see House, No. 4456, amended), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 4 to 0. Sent to the Senate for concurrence.

#### Orders of the Day.

The House Bill to give the town of Leicester authority to grant full annual property tax exemptions to the surviving spouse of Rutland Police Detective and Leicester resident John D. Songy (House, No. 3989), reported by the committee on Bills in the Third Reading to be correctly drawn, was read a third time; and it was passed to be engrossed. Sent to the Senate for concurrence.

House bills Prohibiting gunfire directed at dwelling houses (House, No. 1803); Relative to embarkation fees (House, No. 2873); and Recognizing Sikh appreciation month (House, No. 4569); Severally were read a second time; and they were ordered to a third reading.
