# JOURNAL OF THE HOUSE.

Thursday, September 22, 2022.

Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mr. Garballey of Arlington in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

#### Silent Tribute.

At the request of Ms. Belsito of Topsfield, the members, guests and employees stood in a moment of silent tribute in respect to the memory of Gary David DiScipio, who passed away early Sunday, June 12, 2022, after a brief illness, surrounded by his family.

Mr. DiScipio moved to Topsfield in 1979, from Swampscott, and was a resident of Topsfield for 43 years. Affectionately known as "The Walker" around town, he took great pride in raising his three children and four grandchildren in Topsfield.

Mr. DiScipio, originally from Lynn, born on July 25, 1939, grew up on Mudge Street. He attended Lynn English High School and graduated as a member of the class of 1957. After a year in the Naval Reserves, he went on to own and operate used car lots across the North Shore including in Peabody and Amesbury. He had a magical way of knowing what every car was, from year to make and model. Also, he could tell you any detail you did not want to know about it. He loved all things automotive and his passion led him to a successful career.

## Message from the Governor.

A message from His Excellency the Governor returning with recommendation of amendment the engrossed Bill to reduce traffic fatalities [see House, No. 5103, amended] (for message, see House, No. 5298), was filed in the office of the Clerk on Wednesday, September 21.

The message was read; and, under the provisions of Article LVI of the Amendments to the Constitution, the bill was thereupon "before the General Court and subject to amendment and re-enactment".

the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 3 to 0. Sent to the Senate for concurrence.

Subsequently, the Senate having concurred in adoption of the emergency preamble, the bill (which originated in the House) was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.
