JOURNAL OF THE HOUSE.

Thursday, October 6, 2022.

Met at nine minutes after eleven o'clock A.M., in an Informal Session, with Mr. Donato of Medford in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

At the request of the Chair (Mr. Donato), the members, guests and employees joined with him in reciting the pledge of allegiance to the flag.

They are meeting here in Boston and in Washington to discuss commemoration of 25th anniversary of that agreement, which takes place next year. Also with them was Fiona Calnan, also of Ireland.
