Representative Vargas of Haverhill and Senator DiZoglio presented a joint petition (subject to Joint Rule 12) of Andres X. Vargas and Diana DiZoglio for legislation to establish a sick leave bank for Brittany S. Ketcham, an employee of the Executive Office of Public Safety and Security; and the same was referred, under Rule 24, to the committee on Rules.

Papers from the Senate.

The House Bill amending the charter of the city of Eastham (House, No. 3794) (its title having being changed by the Senate committee on Bills in the Third Reading), came from the Senate passed to be engrossed, in concurrence, with amendments in section 6, in line 80, inserting after the word "town" the words "and on the town's website", in lines 218 and 219, striking out the following: ", 1 of whom shall be appointed under the authority of the commonwealth and 4 of whom shall be elected", in line 665, striking out the figures: "100" and inserting in place thereof the following: "Not less than 100"; and in line 708, inserting after the word "voters" the words "voting in such election". The amendments were referred, under Rule 35, to the committee on Bills in the Third Reading.

Subsequently, under suspension of the rules, on motion of Mr. Michlewitz of Boston, the bill (having been reported by the committee on Bills in the Third Reading to be correctly drawn) was read a third time; and it was passed to be engrossed, its title having been changed by said committee to read: "An Act establishing a task force on sexual assault counsellors. Sent to the Senate for concurrence.

By Mr. Michlewitz of Boston, for the committee on Ways and Means, that the Bill relative to a commission to study the intentional misrepresentation of a service animal (House, No. 1563), ought to pass with an amendment substituting therefor a bill with the same title (House, No. 5364). Referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Mr. Honan of Boston, for said committee, then reported that the matter be scheduled for consideration by the House with the amendment pending.

Under suspension of Rule 7A, on motion of Ms. Whipps of Athol, the bill was read a second time forthwith.

The amendment recommended by the committee on Ways and Means then was adopted; and the substituted bill was ordered to a third reading.

Subsequently, under suspension of the rules, on motion of Mr. Michlewitz of Boston, the bill (having been reported by the committee on Bills in the Third Reading to be correctly drawn) was read a third time; and it was passed to be engrossed. Sent to the Senate for concurrence.

By Mr. Day of Stoneham, for the committee on the Judiciary, on House, Nos. 117, 1479, 1530, 1616, 1643, 1644, 1709, 1819, 1826, 1832, 1900, 1901, 1904, 1905, 1908 and 4347, an Order relative to authorizing the committee on the Judiciary to make an investigation and study of certain House documents relative to victims of crimes, abuse prevention, and other related matters (House, No. 5173). Referred, under Joint Rule 29, to the committees on Rules of the two branches, acting concurrently.
