JOURNAL OF THE HOUSE.

Tuesday, December 27, 2022.

Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mr. Donato of Medford in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

At the request of the Chair (Mr. Donato), the members, guests and employees joined with him in reciting the pledge of allegiance to the flag.

Papers from the Senate.

The engrossed Bill to reduce traffic fatalities (see House, No. 5103, amended), which had been returned by His Excellency the Governor with recommendation of amendments (for message, see House, No. 5298), came from the Senate with the endorsement that said branch had concurred with the House in its amendments with a further amendment striking out all after the enacting clause and inserting in place thereof the text contained in Senate document numbered 3162. The further amendment was referred, under Rule 35, to the committee on Bills in the Third Reading. Said committee then reported that the further amendment was correctly drawn; and it was adopted, in concurrence.

The House Bill further regulating procurements by the city of Boston (House, No. 5039, amended) (its title having been changed by the Senate committee on Bills in the Third Reading), came from the Senate passed to be engrossed, in concurrence, with an amendment in section 1 adding the following paragraph:

"After awarding a contract under this section, the city shall publish notice of such award in the city record or on the city's website.".

The amendment was referred, under Rule 35, to the committee on Bills in the Third Reading. Said committee then reported that the amendment was correctly drawn; and it was adopted, in concurrence.

The House Bill providing for a certain payment in lieu of tax agreement with owners of Pilgrim Nuclear Power Plant in the town of Plymouth (House, No. 4768, amended), came from the Senate passed to be engrossed, in concurrence, with an amendment in line 3 inserting after the word "subsidiaries" the words ", upon the execution of, and in compliance with, an agreement between Holtec Pilgrim, LLC, its subsidiaries and the select board of the town". The amendment was referred, under Rule 35, to the committee on Bills in the Third Reading.

The House Bill relative to the New Bedford Police Association (House, No. 5066), came from the Senate passed to be engrossed, in concurrence, with an amendment in section 2, in line 19, striking out the following: "\$1,000 or \$150" and inserting in place thereof the following: "the greater of: (a) \$1,000; or (b) \$150". The amendment was referred, under Rule 35, to the committee on Bills in the Third Reading.

New Bedford Police Association. The House Bill authorizing the city known as the town of Franklin to grant an additional license for the sale of all alcoholic beverages not to be drunk on the premises (House, No. 5395) (its title having been changed by the Senate committee on Bills in the Third Reading), came from the Senate passed to be engrossed, in concurrence, with an amendment striking out section 2 and inserting in place thereof the following section:

"SECTION 2. Upon the issuance of the license pursuant to section 1, MADD Deli, Inc. doing business as Dacey's Market, located at 353 Lincoln street in the city known as the town of Franklin, shall return physically, with all of the legal rights, privileges and restrictions pertaining thereto, to the licensing authority, the license it currently holds pursuant to chapter 382 of the acts of 2020 for the sale of wines and malt beverages not to be drunk on the premises pursuant to section 15 of chapter 138 of the General Laws."

The amendment was referred, under Rule 35, to the committee on Bills in the Third Reading.

The Senate Bill directing the commissioner of Capital Asset Management and Maintenance to convey certain parcels of land in the city of Lowell to the University of Massachusetts Building Authority (Senate, No. 3158) (on Senate bill No. 3138), passed to be engrossed by the Senate, was read; and it was referred, under Rule 33, to the committee on Ways and Means.

Establishing a sick leave bank for Nicole Sumner, an employee of the Department of Youth Services, and Solange Encarnacion, an employee of the Registry of Motor Vehicles (Senate, No. 3160) (on Senate bill No. 3130);

Severally passed to be engrossed by the Senate, were read; and they were referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

A message from His Excellency the Governor (pursuant to Chapter 127, Section 152 of the Massachusetts General Laws) [sic] a report of the exercise of the pardoning power by the Governor, with the advice and consent of the Council, from January 1, 2022, to December 20, 2022 (Senate, No. 3161), was read for the information of the House and returned to the Senate to be placed on file.

A petition (accompanied by bill) of Michael F. Rush for legislation to establish a sick leave bank for Sean Bruen, an employee of the Trial Court of the Franklin, liquor license.

By the same member, for the same committee, on House, No. 2370, an Order relative to authorizing the committee on Public Health to make an investigation and study of a certain House document relative to COVID-19 vaccinations (House, No. 5443) [Senator Rausch dissenting].

By the same member, for the same committee, on House, Nos. 2307, 2401 and 3926, an Order relative to authorizing the committee on Public Health to make an investigation and study of certain House documents relative to public health matters (House, No. 5444).

Severally referred, under Joint Rule 29, to the committees on Rules of the two branches, acting concurrently.

By Mr. Tucker of Salem, for the committee on Municipalities and Regional Government, on a joint petition, a Bill amending the Arlington town manager act relative to financial estimates and budget reporting (House, No. 5432 [Local Approval Received].

By Mr. Gordon of Bedford, for the committee on Public Service, on a petition, a Bill authorizing Kyle J. Wiley to purchase creditable military service from the Barnstable County Retirement System (House, No. 5410).

Emergency Measure.

The engrossed Bill designating the first Tuesday of October as inflammatory breast cancer awareness day (see House, No. 3147, amended), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 4 to 0. Sent to the Senate for concurrence.

The Senate Bill authorizing the increase of a tax exemption for eligible veterans in the town of Tewksbury (Senate, No. 3115), reported by the committee on Bills in the Third Reading to correctly drawn, was read a third time.

Pending the question on passing the bill to be engrossed, in concurrence, Ms. Garlick of Needham moved to amend it in lines 7 and 8 by striking out the words "annually relative to the most recent exemption amount, as established in the preceding year".

The amendment was adopted; and bill (Senate, No. 3115, amended) was passed to be engrossed, in concurrence. Sent to the Senate for concurrence in the amendment.

The House Bill authorizing the town of Marblehead to amend the general bylaws to add a new chapter 175, elections regarding the order of candidates [sic] names on ballot (printed as Senate, No. 3027), reported by the committee on Bills in the Third Reading to correctly drawn, was read a third time.

Pending the question on passing the bill to be engrossed, Ms. Garlick of Needham moved to amend it by substitution of a Bill relative to the order of candidates' names on the town of Marblehead town election ballots (House, No. 5442), which was read.

The amendment was adopted; and substituted bill was passed to be engrossed. Sent to the Senate for concurrence.
