The engrossed Bill authorizing the town of Norwell to establish a means tested senior citizen property tax exemption (see Senate, No. 1921), having been certified by the Clerk to be rightly and truly prepared for final passage, was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.

Motions to Discharge Certain Matters in the Orders of the Day.

In section 5, in line142, by striking out the figures "\$180,000,000" and inserting in place thereof the figures: "\$175,000,000"; and

By adding the following section:

"SECTION 6. To meet the expenditures necessary to carry out section 2D, the state treasurer shall, upon request of the governor, issue and sell bonds of the commonwealth in an amount to be specified by the governor from time to time, but not exceeding, in the aggregate, \$12,499,000. All bonds issued by the commonwealth under this section shall be designated on their face, 'FutureTech Act of 2024', and shall be issued for a maximum term of years, not exceeding 10 years, as the governor may recommend to the general court under section 3 of Article LXII of the Amendments to the Constitution. All such bonds shall be payable not later than June 30, 2039.".

After remarks on the question on adoption of the consolidated amendments, the sense of the House was taken by yeas and nays, as required under the provisions of House Rule 33F, and on the roll call 152 members voted in the affirmative and 2 in the negative.
