Monday, June 17, 2024.

A message from Her Excellency the Governor recommending legislation (under Article LXXXIX of the Amendments to the Constitution) authorizing the town of Weston to grant an additional license for the sale of all alcoholic beverages to be drunk on the premises (House, No. 4759), was filed in the office of the Clerk on Thursday, June 13.

The message was read; and it was referred, under Rule 30, with the accompanying draft of a bill, to the committee on Consumer Protection and Professional Licensure. Sent to the Senate for concurrence.
