# JOURNAL OF THE HOUSE.

Tuesday, July 2, 2024.

Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mr. Donato of Medford in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

At the request of the Chair (Mr. Donato), the members, guests and employees joined with him in reciting the pledge of allegiance to the flag.

#### Order.

The Order (filed by Mr. Cabral of New Bedford) relative to extending until Friday, July 19, 2024 the time within which the committee on State Administration and Regulatory Oversight is authorized to report on current Senate and House documents, was referred, under Joint Rule 30, to the committees on Rules of the two branches, acting concurrently.

Mr. Galvin of Canton, for the committees on Rules, reported that the order (House, No. 4817), ought to be adopted. Under suspension of the rules, on motion of Mr. Garballey of Arlington, the order was considered forthwith; and it was adopted. Sent to the Senate for concurrence.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 3 to 0. Sent to the Senate for concurrence.
