# JOURNAL OF THE HOUSE.

Monday, July 29, 2024.

Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mr. Donato of Medford in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

At the request of the Chair (Mr. Donato), the members, guests and employees joined with him in reciting the pledge of allegiance to the flag.

During the session, the Chair (Mr. Donato of Medford) declared a brief recess, turned the gavel over to Representative Howard of Lowell. #### Petitions.

Lovely (with the approval of the mayor and city council) that the city of Salem be authorized to convert one annual license for the sale of wine and malt beverages to be drunk on the premises to an annual license for the sale of all alcoholic beverages to be drunk on the premises in said city. By Representative Worrell of Boston, a petition (accompanied by bill, House, No. 4932) of Christopher J. Worrell (with the approval of the mayor and city council) that the city of Boston be authorized to appoint Elsie Barbosa a police officer notwithstanding the maximum age requirement. By Representatives Cabral of New Bedford and Hendricks of New Bedford, a petition (subject to Joint Rule 12) of Antonio F. D. Cabral and Christopher Hendricks that a pedestrian overpass spanning state Route 18 in the city of New Bedford be designated as the Andre Lopes Korean War veteran overpass.

By Representative O'Day of West Boylston and Senator Kennedy, a joint petition (subject to Joint Rule 12) of James J. O'Day and Robyn K. Kennedy relative to further defining a quorum of the Worcester Regional Retirement System Board Advisory Council.

# Papers from the Senate.

The House Bill authorizing the town of Canton to grant temporary and permanent easements of certain land of the town situated in the town of Stoughton for highway purposes (House, No. 3937, amended), came from the Senate, passed to be engrossed, in concurrence, with amendments, striking out all after the enacting clause and inserting in place there of the text contained in Senate document numbered 2897; striking out the title and inserting in place thereof the following title: "An Act authorizing the town of Canton to grant temporary and permanent easements over certain conservation land situated in the town of Stoughton for highway purposes."; and inserting before the enacting clause the following emergency preamble:

"Whereas, The deferred operation of this act would tend to defeat its purpose, which is to authorize forthwith the town of Canton to grant certain easements to the commonwealth for highway purposes, therefore, it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience."

The amendments were referred, under Rule 35, to the committee on Bills in the Third Reading.

The House Bill relative to the direct wine shipper license (House, No. 4698), came from the Senate passed to be engrossed, in concurrence, with an amendment striking out all after the enacting clause and inserting in place thereof the text contained in Senate document numbered 2886. The amendment was referred, under Rule 35, to the committee on Bills in the Third Reading.

Under suspension of Rule 7A, in each instance, on motion of Mr. Gentile of Sudbury, the bills severally were read a second time forthwith; and they were ordered to a third reading.

A report of the committee on Consumer Protection and Professional Licensure, ought NOT to pass (under Joint Rule 10), on the petition (accompanied by bill, House, No. 4796) of James C. Arena-DeRosa (by vote of the town) that the town of Sherborn be authorized to convert one license for the sale of wine and malt beverages not to be drunk on the premises to a license for the sale of all alcoholic beverages not to be drunk on the premises, was considered forthwith, under suspension of the rules, on motion of Ms. Howard of Lowell.

The House then non-concurred with the Senate in its amendment; and, on motion of Mr. Stanley of Waltham, asked for a committee of conference on the disagreeing votes of the two branches. Representatives Stanley, Peisch of Wellesley and Kane of Shrewsbury were appointed the committee on the part of the House. Sent to the Senate to be joined.

Subsequently notice was received from the Senate that said branch had insisted on its amendment, concurred with the House in the appointment of a committee of conference; and that Senators Rodrigues, Jehlen and O'Connor had been joined as the committee on the part of the Senate.

The House Bill authorizing additional licenses for the sale of alcoholic beverages to be drunk on the premises in the city of Boston (House, No. 4696) (its title having been changed by the Senate committee on Bills in the Third Reading), came from the Senate passed to be engrossed, in concurrence, with an amendment striking out all after the enacting clause and inserting in place thereof the text contained in Senate document numbered 2903.

Under suspension of Rule 35, on motion of Mr. Jones of North Reading, the amendment was considered forthwith. The House then non-concurred with the Senate in its amendment; and, on motion of Mr. Michael J. Moran of Boston, asked for a committee of conference on the disagreeing votes of the two branches. Representatives Michael J. Moran, Ryan of Boston and Ferguson of Holden were appointed to the committee on the part of the House. Sent to the Senate to be joined.
