Monday, September 16, 2024.

Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Ms. Barber of Somerville in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

At the request of the Chair (Ms. Barber), the members, guests and employees joined with her in reciting the pledge of allegiance to the flag.

Mr. Galvin of Canton, for said committees, reported, in each instance, asking to be discharged from further consideration of the orders; and recommending that the same severally be referred to the House committee on Rules.

Under Rule 42, the reports were considered forthwith; and they were accepted.

By Mr. Ryan of Boston, for the committee on Election Laws, on a petition, a Bill establishing the recall of elected officials in the town of Williamstown (House, No. 5002) [Local Approval Received].

By Mr. Cahill of Lynn, for the committee on Environment and Natural Resources, on a petition, a Bill facilitating wetland restoration (House, No. 5036).

By Mr. Cusack of Braintree, for the committee on Revenue, on a petition, a Bill allowing the town of Williamstown to expand age eligibility for senior property tax exemption (House, No. 5005, changed in line 2 by striking out the following: "44(c)" and inserting in place thereof the following: "Forty-first C") [Local Approval Received].

Severally read; and referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.
