## JOURNAL OF THE HOUSE.

Monday, November 4, 2024.

Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mr. Donato of Medford in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

At the request of the Chair (Mr. Donato), the members, guests and employees joined with him in reciting the pledge of allegiance to the flag.

#### Paper from the Senate.

A Bill amending Chapter 25 of the Acts of 2023 (Senate, No. 2714) (on Senate, No. 2689) [Local Approval Received], passed to be engrossed by the Senate, was read; and it was referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

#### Reports of a Committee.

By Mr. Chan of Quincy, for the committee on Consumer Protection and Professional Licensure, on House, No. 5026, a Bill extending the time for the issuance of alcoholic beverage licenses in the town of Swansea (House, No. 5092) [Local Approval Received].

By the same member, for the same committee, on House, No. 4931, a Bill authorizing the city of Salem to convert the annual license for the sale of wine and malt beverages to be drunk on the premises pursuant to chapter 75 of the acts of 2008 to an annual license for the sale of all alcoholic beverages to be drunk on the premises (House, No. 5093) [Local Approval Received].

By the same member, for the same committee, on House, No. 4907, a Bill authorizing the town of Tyngsborough to grant 3 additional licenses for the sale of all alcoholic beverages to be drunk on the premises (House, No. 5094) [Local Approval Received].

By the same member, for the same committee, on House, No. 3714, a Bill authorizing the town of Uxbridge to grant 2 additional licenses for the sale of all alcoholic beverages to be drunk off the premises (House, No. 5096) [Local Approval

Severally read; and referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

### Emergency Measure.

The engrossed Bill designating a certain overpass in the city of New Bedford as the Andre Lopes Korean War Veteran overpass (see House, No. 4954, amended), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

New Bedford,— Lopes Korean War Veteran overpass.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 3 to 0. Sent to the Senate for concurrence.

Subsequently, the Senate having concurred in adoption of the emergency preamble, the bill (which originated in the House) was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.

The House Bill authorizing Gustavo Romero to take the civil service examination for the position of police officer in the city of Haverhill notwithstanding the maximum age requirement (House, No. 4860), reported by the committee on Bills in the Third Reading to be correctly drawn, was read a third time.

Pending the question on passing the bill to be engrossed, Mr. Walsh of Peabody moved to amend it in section 1, in lines 5 and 6, by striking out the following sentence: "To be effective for the 2023-2025 law enforcement officer examination results.".

The amendment was adopted; and the bill (House, No. 4860, amended) was passed to be engrossed. Sent to the Senate for concurrence.
