## **CONVENTION**

In the Chamber of the House of Representatives, for the purpose of receiving such communication as Her Excellency Maura T. Healy, Governor of the Commonwealth, may be pleased to make relative to the concerns of the Commonwealth; and were called to order by the Honorable Karen E. Spilka, President of the Senate.

## Order Adopted.

On motion of Mr. Rush,—

Ordered, That a committee be appointed to consist of members of the Senate and House of Representatives to wait upon Her Honor the Lieutenant-Governor, the Constitutional officers, members of the Executive Council and other distinguished guests of the Governor and inform them that the two branches are now in Convention and request the honor of their presence.

Senators Brownsberger, Friedman, Collins, Oliveira and Tarr were appointed on the part of the Senate; and Representatives Gregoire of Marlborough, Cruz of Salem, Barber of Somerville, Domb of Amherst, Scanlon of North Attleborough, LaNatra of Kingston, John Francis Moran of Boston, Chan of Quincy, Smola of Warren, Frost of Auburn and Kane of Shrewsbury were appointed on the part of the House.

Subsequently, Ms. Friedman, for the committee, reported that the Constitutional officers, the Executive Council and distinguished guests would immediately attend upon the convention.

Shortly thereafter, Her Honor the Lieutenant-Governor, Kim Driscoll, the Constitutional officers, members of the Executive Council and cabinet members entered the Chamber under the escort of the Sergeant-at-Arms.

The President in the Chair, then introduced Father John J. Unni, Pastor of Saint Cecilia Church in Boston, who delivered the following Invocation:

Good evening everyone. I am Reverand John Unni, Pastor of Saint Cecilia's Parish in Boston and Chaplain for the Boston Fire Department. Thank you Governor Healey for this honor. So—two collections and this will go about an hour and a half...

As we gather for the State of the Commonwealth tonight, each year brings us many new and similar realities: issues or war and peace, equity and inequity, challenges and opportunities, hopelessness and hope.

So tonight let us be a people of hope even though there can be so much to bring us down individually and collectively. But lets also be realists in our abilities to exercise our role, our freedom and our responsibilities, to continue to this this Commonwealth a good and even better place to be, live and to work.

With all the strife that is rising in the world, in our own country, with terror, with vengeance and retaliation, with all that can dampen and squash our spirits, we must be a people of hope. And we do this best by being individuals, people of decency, honesty, integrity and authenticity. I don't pitch a perfect game, but it is something for which we are all striving.

We need not only to speak of love and compassion but to somehow exercise and promote it and to live it as best we can. We do this by taking care of each other, whatever that means. People who are new to this country and those who have been here forever. By taking care of the environment as our climate changes. I thought tonight, especially as the Chaplain on the Boston Fire, tonight, we especially hold in our hearts, our sisters and brothers in California who have been totally devastated by these wildfires. We pray for those who are fighting the fires, the ones coordinating the efforts those who are responding first as police, EMS and so many other public servants. May we never take for granted how important it is that we take care of one another, especially in the most devastating and vulnerable of times. West Coast – East Coast – in the middle, all of us I think we do this best by not judging but helping, by sharing and empowering, not sniping and fearing.

The challenges of our Commonwealth our country and our world require good, honest, smart, committed leaders to creatively and effectively tackle big problems and big opportunities. We need leaders who are creative, dignified and effective ways. Always recognize the dignity of every human being person first, and then, figure out how to remedy their situations.

So tonight, calling on the God of understanding from our many different beautiful, diverse, faith backgrounds, as we pray:

Lord God, it is from you that each of us has life, purpose and mission in this world. We are not the center of the universe, but each of us has been created by you to do good, and to do it well, as best we can in the time we have been given So we ask you to bless this evenings gathering. Bless and inspire our Governor, Maura Healey, Lieutenant Governor, Kim Driscoll, the legislators, all the elected officials, the cabinet and all in Leadership in this Commonwealth.

Continue to guide the Governor and all of our elected officials with your spirit, which is a spirit of wisdom, knowledge, understanding, heart smarts, with a spirt of gentle strength, compassion and understanding, as we take care of each other, as we step up to our responsibilities, exercise our duties and keep the dignity of every human being in mind as we go forward with these solutions to complex issues, many with simultaneously competing realities at play.

Lastly, as we do this Lord, may we not be afraid, may we not be fear based or vengeful, but may we work together with a spirit of cooperation, always assuming

positive intent being realistic and generous as we face each day in the commonwealth, showing mercy, acting justly and walking humbly with our God.

Please join me in praying for the well-being of the Governor and Lt. Governor, for the elected officials here today, and for all the elected officials and civil servants across the Commonwealth and our country.

May God, source of justice, truth, and love, before Whom every human leader stands — bless these leaders with the wisdom, discernment, and good judgment to make impossible decisions guided by vision, values, and love for the people they serve.

We are living in fragile times. The problems we face — locally and globally, including natural disasters and war — have no simple solutions, yet require focused, patient, relentless commitment to making the world a better place. In that spirit, I would be remiss if I did not acknowledge the dramatic progress made yesterday toward returning the hostages and achieving a ceasefire in Gaza. God, may every one of them return home to their families, and may everyone be able to live with dignity, security, and peace.

Times like these can disincentivize well-meaning people from taking on positions of leadership and dedicating their lives to public service. Which is precisely why the work of this chamber is so sacred and so desperately needed right now.

May God bless these leaders with curiosity and open-mindedness, so they may pursue truth and a deeper understanding of our complex world; bless them with patience and compassion for all of us, the citizens for whom they are responsible and whose lives are in their hands. May they find meaning, purpose, and joy in their service, for which we are deeply grateful.

God, let us also remember that the sacred work of building and rebuilding our society is a collective responsibility. This great country was founded on the ideal of a covenantal partnership between we the people and the leaders we have elected to lead us.

When our challenges feel overwhelming, we can be tempted to paralysis or despair. This week, Jews around the world will begin reading the Book of Exodus, which describes the journey from slavery to freedom, from bitterness to joy, from darkness to light. The Exodus story gave us a revolutionary idea: HOPE. Hope is the belief that we are never doomed by the past nor stuck in the present, that the world can be better tomorrow than it is today, and that, like Moses at the burning bush, every one of us has a role and responsibility in making that happen. We have the agency, the power, the God-given creative capacity to change our lives and our world for the better.

And how do we do this? We begin with what in Hebrew is called a cheshbon hanefesh — a reckoning of the soul — an honest look in the mirror and into our own hearts. For it is here, inside each of us, where the work of repairing the world begins. One choice at a time, one relationship at a time, each of us asking ourselves: What can I do today?

May God — source of justice, truth, and love, before Whom every one of us stands — bless each of us, the citizens of this Commonwealth and this great nation, that we may be the people our leaders deserve; grant us the patience and resilience to keep building a better future; give us the moral and spiritual fortitude to fight for the values we hold dear and against those who seek to cause us harm, while protecting every person's dignity and humanity.

God, let us recommit ourselves to all that unites us, let us reweave the ties that bind us; together, let us write the creative, joyful, life-affirming story of our collective future.

And let us say: Amen. Thank you.
