JOURNAL OF THE HOUSE.

Monday, February 2, 2026.

Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mr. Donato of Medford in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

Message from the Governor.

A message from Her Excellency the Governor submitting requests for making appropriations for the fiscal year 2026 to provide for supplementing certain existing appropriations and for responding to recent federal actions (House, No. 5050), was filed in the office of the Clerk on Thursday, January 29.

The message was read; and it was referred, under Rule 30, with the accompanying draft of a bill, to the committee on Ways and Means.

The Speaker announced that (under the provisions of Section 68 of Chapter 3 of the General Laws) he had reappointed Amy Goh of Boston, Christopher Huang of Quincy and Jennifer Rubin of Newton to the permanent Commission on the status of Asian Americans and Pacific Islanders.
