# JOURNAL OF THE HOUSE.

Wednesday, June 18, 2025.

Met according to adjournment at eleven o'clock A.M. with Mr. Donato of Medford in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

At the request of the Chair (Mr. Donato), the members, guests and employees joined with him in reciting the pledge of allegiance to the flag.

### Silent Tributes.

During the session, the Speaker took the Chair and at the request of Speaker Mariano and Minority Leader Jones, the members, guests, and employees stood in a moment of silent tribute for Minnesota Speaker Emerita Melissa Hortman who was tragically killed along with her husband, Mark Hortman, in an act of political violence on June 14th, 2025.

Speaker Hortman served as a State Representative in Minnesota from 2005 until 2025, and as Speaker from 2019 until January of this year.

A graduate of Boston University in 1991, University of Minnesota School of Law in 1995, and Harvard Kennedy School in 2018, Speaker Hortman served her district with distinction, and her death is both a devastating loss for Minnesota, and for the country as a whole.

Speaker Hortman and her husband are survived by their two children, Colin and Sophie.

During the session, Ms. Hogan of Stow being in the Chair, at the request of Representatives Giannino of Revere, Turco of Winthrop and Galvin of Canton, the members, guests and employees stood in a moment of silence in memory of Richard Serino, Sr. of Revere, who tragically lost his life yesterday.

He was a devoted husband to his beloved wife, a loving father and proud grandfather, a United States Marine Corps veteran, and a retired Revere police officer who dedicated his life to service. Enlisting in 1967, he served honorably during the Vietnam era, including a tour in Okinawa. Upon returning to Revere, he served for over 30 years as a patrolman, known throughout the city as the motorcycle traffic officer.

Richie was known not only for his public service, but also for his kindness, patriotism, and festive spirit, bringing joy to his neighbors through his holiday lawn displays. He leaves behind his wife Trudy, his children, grandchildren, and a grateful community who mourn his loss and honor his legacy.

## Petition.

Representative Whipps of Athol and Senator Comerford presented a joint petition (accompanied by bill, House, No. 4228) of Susannah M. Whipps and Joanne M. ### Paper from the Senate.

A petition (accompanied by bill, Senate, No. 2532) of Michael F. Rush, Edward R. Philips, Marcus S. Vaughn, John H. Rogers and other members of the General Court (by vote of the town) for legislation to authorize the town of Walpole to grant up to 2 additional licenses for the sale of all alcoholic beverages not to be drunk on the premises, was referred, in concurrence, to the committee on Consumer Protection and Professional Licensure.

## Reports of Committees.

By Mr. Galvin of Canton, for the committee on Rules and the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the petition of Kevin G. Honan and Michael J. Moran for legislation to establish a sick leave bank for James Caruso, an employee of the Massachusetts Department of Transportation. Under suspension of the rules, on motion of Mr. Ultrino of Malden, the report was considered forthwith. Joint Rule 12 then was suspended; and petition (accompanied by bill) was referred to the committee on Public Service. Sent to the Senate for concurrence.

At six minutes after eleven o'clock A.M., on motion of Mr. Wong of Saugus (Mr. Donato of Medford being in the Chair), the House recessed until one o'clock P.M.; and at five minutes after one o'clock, the House was called to order with Ms. Hogan of Stow in the Chair.

By Mr. Honan of Boston, for the committee on Steering, Policy and Scheduling, that the House Bill establishing a sick leave bank for Esther Odufuwa an employee of the department of mental health (House, No. 4222), be scheduled for consideration by the House.

Under suspension of the rules, on motion of Mr. Jones of North Reading, the bill was read a second time forthwith; and it was ordered to a third reading.

Subsequently (Mr. Donato of Medford being in the Chair) under suspension of the rules, on motion of Ms. Fiola of Fall River, the bill (having been reported by the committee on Bills in the Third Reading to be correctly drawn) was read a third time; and it was passed to be engrossed, its title having been changed by said committee to read: "An Act establishing a sick leave bank for Esther Odufuwa, an employee of the department of mental health." Sent to the Senate for concurrence.

## Orders of the Day.

After remarks on the question on acceptance of the report, the sense of the House was taken by yeas and nays, at the request of Mr. Michlewitz of Boston; and on the roll call 150 members voted in the affirmative and 3 in the negative.

# Emergency Measure.

The engrossed Bill making appropriations for the fiscal year 2025 to provide for supplementing certain existing appropriations and for certain other activities and projects (see House, No. 4227), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

Supplemental appropriations.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 46 to 0. Sent to the Senate for concurrence.

On the question on passing the bill to be enacted (Mr. Donato of Medford being in the Chair), the sense of the House was taken by yeas and nays, at the request of Mr. Michlewitz of Boston; and on the roll call (Speaker Mariano having taken the Chair) 148 members voted in the affirmative and 4 in the negative.

Bill enacted,—yea and nay No. 57.
