## Message from the Governor.

A message from Her Excellency the Governor recommending legislation relative to empowering municipalities and local governments (House, No. 56) was filed in the office of the Clerk on Friday, January 31.

The message was read; and, along with the accompanying draft of a bill, and it was referred, under Rule 30, as follows:

So much as relates to sections 1 to 17, inclusive, 20 to 44, inclusive, 73 to 82, inclusive, and 87 — to the committee on Municipalities and Regional Government;

So much as relates to sections 18, 19, 83, 84 and 88— to the committee on Public Service; and

So much as relates to sections 45 to 72, inclusive, 85 and 86 — to the committee on Revenue.
