By Mr. Day of Stoneham, for the committee on the Judiciary, ought NOT to pass, on the petition (accompanied by bill, House, No. 1722) of John R. Gaskey relative to repealing the legal parentage equality act. Referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Legal parentage.

At sixteen minutes after eleven o'clock A.M., on motion of Mr. Muradian of Grafton (Mr. Donato of Medford in the Chair) the House recessed until one o'clock P.M.; and twenty-eight minutes before two o'clock, the House was called to order with Ms. Hogan of Stow in the Chair.

Prior to the noon recess (Mr. Donato of Medford in the Chair), By Mr. Michlewitz of Boston, for the committee on Ways and Means, that the Bill relative to benefits for teachers (House, No. 2932), ought to pass with an amendment substituting therefor a bill with the same title (House, No. 4361). Referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Mr. Honan of Boston, for said committee, then reported that the matter be scheduled for consideration by the House.

Under suspension of Rule 7A, on motion of Mr. Michlewitz of Boston, the bill was read a second time forthwith. The amendment recommended by the committee on Ways and Means then was adopted; and the substituted bill was ordered to a third reading.

Subsequently, the noon recess having terminated (Ms. Hogan of Stow being in the Chair), under suspension of rules, on motion of Mr. Jones of North Reading, the bill (having been reported by the committee on Bills in the Third Reading to be correctly drawn) was read a third time.

After debate on the question on passing the bill to be engrossed, the sense of the House was taken by the yeas and nays, at the request of Mr. Ryan of Boston; and the roll call 158 members voted in the affirmative and 0 in the negative.

Under suspension of Rule 7A, on motion of Mr. Michlewitz of Boston, the bill was read a second time forthwith. The amendment recommended by the committee on Ways and Means then was adopted; and the substituted bill was ordered to a third reading.

Hospitality workers,—training.

Subsequently, the noon recess having terminated (Ms. Hogan of Stow being in the Chair), under suspension of rules, on motion of Mr. Jones of North Reading, the bill (having been reported by the committee on Bills in the Third Reading to be correctly drawn) was read a third time.

After debate on the question on passing the bill to be engrossed, Mr. Ryan of Boston moved to amend it in section 6C, in lines 22, 23, and 24, by striking out the following: "(ii) how human trafficking is defined pursuant to sections 50 and 51 of chapter 265; and (iii) how to identify a human trafficking victim, as defined in section 20M of chapter 233."; and inserting in place thereof the following: "(ii) how human trafficking is defined pursuant to sections 50 and 51 of chapter 265 or the federal Victims of Trafficking and Violence Protection Act of 2000; (iii) how to identify victims of human trafficking, as defined pursuant to section 20M of chapter 233 or said federal act."

The amendment was adopted.

On the question on passing the bill, as amended, to be engrossed, the sense of the House was taken by yeas and nays, at the request of Mr. Walsh of Peabody; and on the roll call 158 members voted in the affirmative and 0 in the negative.
