### JOURNAL OF THE HOUSE.

Monday, September 15, 2025.

Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mr. Garballey of Arlington in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

We condemn this senseless act and urge a return to civil discourse, where opposing views can be freely exchanged and debated without the threat of violence.

#### Resolutions.

#### Papers from the Senate.

A report of the committee on Environment and Natural Resources, asking to be discharged from further consideration of the petition (accompanied by bill, Senate, No. 602) of Dylan A. Fernandes, Michael D. Brady and Julian Cyr for legislation relative to a cranberry water use transfer program,—and recommending that the same be referred to the committee on Agriculture and Fisheries,—accepted by the Senate, was considered forthwith, under Rule 42; and it was accepted, in concurrence.

Pending the question on passing the bill to be engrossed, Mr. Walsh of Peabody moved to amend it by inserting before the enacting clause the following emergency preamble:

"Whereas, The deferred operation of this act would tend to defeat its purpose, which is to designate forthwith the month of September as Polycystic Ovary Syndrome Awareness Month, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience."

The amendment was adopted; and the bill (House, No. 3392, amended) was passed to be engrossed. Sent to the Senate for concurrence.
