Pending the question on passing the bill to be engrossed, Mr. Walsh of Peabody moved to amend it by substitution of a bill with the same title (House, No. 4542), which was read.

to be correctly drawn, was read a third time.

The amendment was adopted; and the substituted bill was passed to be engrossed. Sent to the Senate for concurrence.

The House Bill designating veterans suicide awareness and remembrance day (House, No. 3388), reported by the committee on Bills in the Third Reading to be correctly drawn, was read a third time.

Veterans suicide day.

Pending the question on passing the bill to be engrossed, Mr. Walsh of Peabody moved to amend it by inserting before the enacting clause the following emergency preamble:

"Whereas, The deferred operation of this act would tend to defeat its purpose, which is to designate forthwith September 22 as Military Service Members and Veterans Suicide Awareness and Remembrance Day, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience."

The amendment was adopted; and the bill (House, No. 3388, amended) was passed to be engrossed. Sent to the Senate for concurrence.

Recess.

At thirteen minutes after eleven o'clock A.M., on motion of Mr. Wong of Saugus (Mr. Donato of Medford being in the Chair), the House recessed subject to the call of the Chair; and at ten minutes after one o'clock P.M., the House was called to order with Mr. Donato in the Chair.

Emergency Measures.

The engrossed Bill making appropriations for fiscal year 2025 to provide for supplementing certain existing appropriations and for certain other activities and projects (see House, No. 4530), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

Supplemental appropriations.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 2 to 0. Sent to the Senate for concurrence.

Subsequently, the Senate having concurred in adoption of the emergency preamble, the bill (which originated in the House) was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.

Bill enacted.

The engrossed Bill establishing the 2026 state primary election date (see House, No. 4531), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

State primary election date.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 2 to 0. Sent to the Senate for concurrence.

Subsequently, the Senate having concurred in adoption of the emergency preamble, the bill (which originated in the House) was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.

Bill enacted.

Engrossed Bill.

The engrossed Bill designating July 2 as Machado-Joseph Disease Awareness Day (see House, No. 3298) (which originated in the House), having been certified by the Clerk to be rightly and truly prepared for final passage, was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.
