Silent Tribute.

At the request of Representative Biele of Boston, the members, guests and employees stood in a moment of silent tribute to the memory of John "Jack" Linehan, who passed away on August 13, at the age of 93 after a long and courageous battle with dementia.

John "Jack" Linehan.

Born in South Boston to Irish immigrants during the Great Depression, Jack dropped out of school after the death of his father, Cornelius, to help support his mother, Elizabeth, and his five siblings.

After serving in the United States Army during the Korean War, Jack was transferred to Japan where he met his wife. After an honorable discharge from the Army, they moved back to South Boston where they raised their four children. Upon returning home, Jack worked as a custodian for Boston Public Schools for almost 40 years.

Husband of the late Kyoko (Honda) Linehan and devoted father of Kathy, John, Paul, and Mark, Jack is survived by his grandchildren, Timothy, Melissa, Jessica, Kai, Cade, Amanda, and Stephen, his great grandchildren, Tommy and Erin, and many nieces and nephews.
