Thursday, October 2, 2025.

Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mr. Donato of Medford in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

A lifelong resident of Fall River, Clara dedicated her life to service—first as a licensed practical nurse at Saint Anne's Hospital, and later as legislative aide to State Representative Alan Silvia. In this role, she became a trusted advocate for the community, known for her compassion, fairness, and dedication.

Beyond her professional life, she was active in civic life, serving as vice president of the Fall River Garden Club, a board member of the Friends of the Fall River Public Library, and a member of the Carousel Lions Club. A devout Catholic and parishioner of Good Shepherd Parish, Clara also found strength in her faith. She leaves behind her children, grandchildren, and extended family, who carry forward her legacy of love, service, and devotion.
