Marsi (with the approval of the town council) for legislation to further regulate the granting of additional licenses for the sale of all alcoholic beverages to be drunk on the premises in the city known as the town of Southbridge. Ordered, That, notwithstanding the motion previously adopted during the Joint Session of May 14, 2025 to recess the joint session until Wednesday, October 8, 2025 and notwithstanding any special rules to the contrary, the joint session of the two houses is hereby recessed until Thursday, October 9, 2025 at a half past eleven o'clock A.M.

A petition (accompanied by bill, Senate, No. 2626) of Robyn K. Kennedy and Meghan K. Kilcoyne (by vote of the town) for legislation relative to the select board of the town of Berlin, was referred, in concurrence, to the committee on Municipalities and Regional Government.

A petition (accompanied by bill) of Cindy F. Friedman for legislation to adjust the MBTA assessment, came from the Senate referred, under suspension of Joint Rule 12, to the committee on the Transportation.

The House then concurred with the Senate in the suspension of said rule; and the petition (accompanied by bill, Senate, No. 2629) was referred, in concurrence, to the committee on the Transportation.

Joint Rule 12 then was suspended; and petition (accompanied by bill) was referred to the committee on Consumer Protection and Professional Licensure. Sent to the Senate for concurrence.

By Mr. Honan of Boston, for the committee on Steering, Policy and Scheduling, that the following House bills be scheduled for consideration by the House:
