Thursday, October 9, 2025.

Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mr. Donato of Medford in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

At the request of the Chair (Mr. Donato), the members, guests and employees joined with him in reciting the pledge of allegiance to the flag.

Resolutions.

Resolutions (filed with the Clerk by Representative Jones of North Reading) commending the AADC Family Network in acknowledging October 23, 2025 as AADC Deficiency Awareness Day in Massachusetts, were referred, under Rule 85, to the committee on Rules.

AADC day.

Mr. Galvin of Canton, for said committee, reported that the resolutions ought to be adopted. Under suspension of the rules, on motion of Mr. Ouelette of Westport, the resolutions (reported by the committee on Bills in the Third Reading to be correctly drawn) were considered forthwith; and they were adopted.

Order.

An Order (filed by Representatives Vargas of Haverhill and Hong of Lowell) relative to extending until Sunday, November 23, 2025 the time within which the committee on Community Development and Small Businesses is authorized to report on current House documents, was referred, under Rule 24, to the committee on Rules.

Mr. Galvin of Canton, for the committee on Rules, reported that the order (House, No. 4595) ought to be adopted. Under suspension of the rules, on motion of Mr. Hong of Lowell, the order was considered forthwith; and it was adopted.

Paper from the Senate.

A petition (accompanied by bill) of Paul W. Mark for legislation to promote energy conservation in residential buildings through the installation of energy-conserving windows, came from the Senate referred, under suspension of Joint Rule 12, to the committee on Housing.

The House then concurred with the Senate in the suspension of said rule; and the petition (accompanied by bill, Senate, No. 2644) was referred, in concurrence, to the committee on Housing.

By Mr. Honan of Boston, for the committee on Steering, Policy and Scheduling, that the following House bills be scheduled for consideration by the House:

Under suspension of Rule 7A, in each instance, on motion of Mr. Ouelette of Westport, the bills severally were read a second time forthwith; and they were ordered to a third reading.

A report of the committee on Steering, Policy and Scheduling, under the last sentence of Rule 7A, that the House Bill relative to primary insurance (House, No. 1301), be scheduled for consideration by the House (the time within which said committee is required to report having expired).

Under suspension of Rule 7A, on motion of Mr. Ouelette of Westport, the bill was read a second time forthwith: and it was ordered to a third reading.

By Mr. Cabral of New Bedford, for the committee on State Administration and Regulatory Oversight, on House, Nos. 3384 and 3393, an Order relative to authorizing the committee on State Administration and Regulatory Oversight to make an investigation and study of certain House documents relative to state agency language access and inclusion and removing certain accessibility restrictions on public records (House, No. 4564). Referred, under Joint Rule 29, to the committees on Rules of the two branches, acting concurrently.

Subsequently, Mr. Galvin of Canton, for said committees, reported asking to be discharged from further consideration of the order; and recommending that the same be referred to the House committee on Rules.

Under Rule 42, the report was considered forthwith; and it was accepted.

The House Bill amending the charter of the city known as the town of Agawam to strike the reference to the board of appeals (House, No. 4380), reported by the committee on Bills in the Third Reading to be correctly drawn, was read a third time.

Pending the question on passing the bill to be engrossed, Mr. Walsh of Peabody moved to amend it in section 2, in line 8, by striking out the following: "2025 regular election" and inserting in place thereof the following: "next regular or special election following the 2025 regular election"; and

By adding the following section:

"SECTION 4. Sections 2 and 3 shall take effect upon passage of this act.".

The amendments were adopted; and the bill (House, No. 4380, amended) was passed to be engrossed. Sent to the Senate for concurrence.
