Tuesday, November 18, 2025.

Silent Prayer.

During the session (Ms. Hogan of Stow being in the Chair), at the request of Representatives Sangiolo of Newton, Schwartz of Newton and Lawn of Watertown, the members, guests and employees stood in a moment of silent tribute in respect to the memory of Setti David Warren, Newton's 30th mayor, who died unexpectedly on Sunday, November 2nd at the family's Beaumont Avenue home. He was fifty-five years old.

At the time of his death, he was the Director of the Institute of Politics and Adjunct Lecturer in Public Policy at Harvard's Kennedy School of Government. Before his appointment, he was Executive Director of the Shorenstein Center on Media, Politics and Public Policy. In 2009, he was elected Mayor of Newton — the first African American mayor in Massachusetts.

Mayor Warren led a life of public service, working as New England Director of the Federal Office of Emergency Management, and as deputy director of Senator John Kerry's Boston office. He also served in Iraq as a Naval Intelligence specialist.

Mayor Warren is survived by his wife Tassy, his children, Abigail and John, and his twin sister, Makeda.

At eleven minutes after eleven o'clock P.M., on motion of Mr. Wong of Saugus (Mr. Donato of Medford being in the Chair), the House recessed until one o'clock P.M.; and two minutes after one o'clock, the House was called to order with Mr. Donato of Medford in the Chair.

By Mr. Michlewitz of Boston, for the committee on Ways and Means, that the Senate Bill relative to amending certain use restrictions for the Foxborough State Hospital (Senate, No. 2141), ought to pass with amendments by striking out all after the enacting clause and inserting in place thereof the text contained in House document numbered 4765; by inserting the following emergency preamble:

“Whereas, The deferred operation of this act would tend to defeat its purpose, which is to authorize forthwith the release or amendment of certain use restrictions of land in the town of Foxborough, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience.”; and by striking out the title and inserting in place thereof the following title: “An Act relative to the release or amendment of certain use restrictions for the Foxborough State Hospital.”. Referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Mr. Honan of Boston, for said committee, then reported that the matter be scheduled for consideration by the House.

Under suspension of Rule 7A, on motion of Mr. Michlewitz of Boston, the bill was read a second time forthwith. The amendments recommended by the committee on Ways and Means then were adopted; and the bill (Senate, No. 2141, amended) was ordered to a third reading.

By Mr. Michlewitz of Boston, for the committee on Ways and Means, that the Senate Bill authorizing the commonwealth to dispose of certain parcels of land in the town of Upton acquired for conservation and recreation purposes (Senate, No. 2576), ought to pass with an amendment by striking out all after the enacting clause and inserting in place thereof the text contained in House document numbered 4766. Referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Under suspension of Rule 7A, on motion of Mr. Michlewitz of Boston, the bill was read a second time forthwith. The amendment recommended by the committee on Ways and Means then was adopted; and the substituted bill was ordered to a third reading.

At six minutes after one o'clock P.M., on motion of Mr. Jones of North Reading (Mr. Donato of Medford being in the Chair), the House recessed subject to the call of the Chair; and twenty-two minutes after two o'clock, the House was called to order with Ms. Hogan of Stow in the Chair.

Under suspension of Rule 7A, on motion of Mr. Michlewitz of Boston, the bill was read a second time forthwith.

The amendment recommended by the committee on Ways and Means,— that the bill be amended by substitution of a bill with the same title (House, No. 4750),— then was adopted; and the substituted bill was ordered to a third reading.

Subsequently, the afternoon recess having terminated (Ms. Hogan of Stow being in the Chair), under suspension of the rules, on motion of Mr. Finn of West Springfield, the bill (having been reported by the committee on Bills in the Third Reading to be correctly drawn) was read a third time.

After debate on the question on passing the bill to be engrossed, Mr. Michlewitz of Boston and other members of the House moved to amend it in section 2 by inserting after item 7066-8006 the following item:

“7066-8007 For higher education capital projects; provided, that not less than \$5,000,000 shall be expended for Greenfield Community College; provided further, that not less than \$2,000,000 shall be expended for Northern Essex Community College facilities for high school career and technical education, including construction, renovation, modernization, equipment acquisition, and instructional technology to expand regional vocational pathways; provided further, that not less than \$2,000,000 shall be expended for the renovation of Tillinghast hall at Bridgewater State University; provided further, that not less than \$350,000 shall be expended for the University of Massachusetts Boston to support the renaming of the center for African, Caribbean and community development as the Senator Bill Owens center, including installation of markers and commemorative programming; provided further, that not less than \$10,000,000

shall be expended for the renovation of the Sullivan building at Salem State University; provided further, that not less than \$20,000,000 shall be expended for Middlesex Community College for the expansion, modernization and development of the life sciences center on the Bedford campus; provided further, that not less than \$10,000,000 shall be expended for Framingham State University to renovate, maintain and modernize the Henry Whittemore library; provided further, that not less than \$5,000,000 shall be expended to Springfield Technical Community College; provided further, that not less than \$500,000 shall be expended for the UMass cranberry station to undertake modernization and deferred maintenance projects at cranberry bogs that they utilize; provided further, that not less than \$10,000,000 shall be expended to the Dudley house at Roxbury Community College; provided further, that not less than \$20,000,000 shall be expended for Bunker Hill Community College to renovate their chemistry, biology and engineering classrooms and prep rooms; provided further, that not less than \$100,000,000 shall be expended for the construction of the Westfield State University human health hub; provided further, that not less than \$200,000 shall be expended for renovations and upgrades to 6 classrooms at Bay Path University; provided further, that not less than \$50,000,000 shall be expended for upgrading UMass Boston learning spaces infrastructure and technology; provided further, that not less than \$5,000,000 shall be expended for renovation of the McKay complex at Fitchburg State University; provided further, that not less than \$5,000,000 shall be expended for Conlon hall at Fitchburg State University; provided further, that not less than \$200,000 shall be expended to Bay Path University in support of the expansion of their nursing program, which will address the critical shortage experienced in Massachusetts by funding the purchase of key equipment; provided further, that not less than \$20,000,000 shall be expended for the renovation and expansion of the student center at Worcester State University; provided further, that not less than \$3,000,000 shall be expended for Carey building window replacement at Massachusetts Bay Community College; provided further, that not less than \$2,200,000 shall be expended for HVAC System Replacement at Massachusetts bay Community College; provided further, that not less than \$25,000,000 shall be expended for the Lowell innovation network corridor project at the University of Massachusetts at Lowell; provided further, that not less than \$400,000 shall be expended for outdoor court upgrades located at Bristol Community College's Fall River campus; provided further, that not less than \$20,000,000 shall be expended to renovate and expand the Massachusetts maritime academy student wellness, recreation and workforce development center; provided further, that not less than \$22,500,000 shall be expended to support drainage, resurfacing, and soil mitigation efforts at Quinsigamond Community College; provided further, that not

less than \$5,000,000 be expended for the renovation of the Haley first floor student success center at Mount Wachusett Community College; provided further, that not less than \$5,000,000 shall be expended for a fitness center at Mount Wachusett Community College; provided further, that not less than \$2,000,000 shall be expended for renovations to the Peter Asiaf field house at Mount Wachusett Community College; provided further, that not less than \$100,000 shall be expended for the University of Massachusetts Amherst to expand classroom space at the Henry M. Thomas III center in Springfield; and provided further, that not less than \$20,000,000 shall be expended for Northern Essex Community College facilities for high school career and technical education.....\$370,450,000”.

On the question on adoption the amendments, the sense of the House was taken by yeas and nays, as required under the provisions of House Rule 33F; and on the roll call 149 members voted in the affirmative and 4 in the negative.

On the question on passing the bill, as amended, to be engrossed, the sense of the House was taken by yeas and nays, at the request of Mr. Rogers of Cambridge; and on the roll call 148 members voted in the affirmative and 5 in the negative.
