Monday, December 1, 2025.

Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mr. Garballey of Arlington in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

A message from Her Excellency the Governor returning with recommendation of amendment the engrossed Bill increasing the membership of the board of health of the town of Marblehead from three members to five [see House, No. 3912] (for message, see House, No. 4798), was filed in the office of the Clerk on Wednesday, November 26.

The message was read; and, under the provisions of Article LVI of the Amendments to the Constitution, the bill was thereupon "before the General Court and subject to amendment and re-enactment".

Pending the question on adoption of the amendment recommended by Her Excellency, the bill was referred, on motion of Mr. Walsh of Peabody, to the committee on Bills in the Third Reading.

The engrossed Bill establishing a sick leave bank for David A. Russell, an employee of the Department of Correction (see House, No. 4587), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 3 to 0. Sent to the Senate for concurrence.

Subsequently, the Senate having concurred in adoption of the emergency preamble, the bill (which originated in the House) was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.
