Thursday, December 4, 2025.

returned by Her Excellency the Governor pursuant to Article LVI of the Amendments to the Constitution with recommendation of amendment (for message, see House, No. 4798), was considered.

The committee on Bills in the Third Reading reported recommending that the amendment recommended by the Governor be considered in the following form:

The second sentence of section 1 is hereby amended by striking out the word "select".

The report was accepted. The amendment recommended by the Governor then was adopted. Sent to the Senate for its action.

The House Bill changing certain instances of the name of the inland fisheries and game fund to the George L. Darey Inland Fisheries and Game Fund (House, No. 1064) (its title having been changed by the committee on Bills in the Third Reading), reported by said committee to be correctly drawn, was read a third time.

Inland Fisheries and Game Fund.

Pending the question on passing the bill to be engrossed, Mr. Walsh of Peabody moved to amend it by striking out section 5 and inserting in place thereof the following section:

"SECTION 5. Section 2B of said chapter 131, as so appearing, is hereby amended by striking out the words 'Inland Fisheries and Game Fund', each time they appear, and inserting in place thereof, in each instance, the following words: George L. Darey Inland Fisheries and Game Fund."; and

By striking out section 10 and inserting in place thereof the following section:

"SECTION 10. Chapter 101 of the acts of 2003 is hereby amended by striking out section 14 and inserting in place thereof the following section:

Section 14. Notwithstanding any general or special law to the contrary, any reference to the Inland Fisheries and Game Fund or the Inland Fish and Game Fund in any general or special law shall mean the George L. Darey Inland Fisheries and Game Fund, established by section 2C of chapter 131 of the General Laws.".

The amendments were adopted; and the bill (House, No. 1064, amended) was passed to be engrossed. Sent to the Senate for concurrence.
