Papers from the Senate.

The House Bill increasing the age limit for retired police officers serving as special police officers in the town of Weston (House, No. 4031), came from the Senate passed to be engrossed, in concurrence, with an amendment striking out all after the enacting clause and inserting in place thereof the text contained in Senate document numbered 2860. The amendment was referred, under Rule 35, to the committee on Bills in the Third Reading.
