Committee Change.

Notice was received from the President that he had appointed Senator Menard of Bristol to the first position on the joint standing committee on Federal Financial Assistance. The membership of the committee is as follows: Senators Menard of Bristol, Panagiotakos of Middlesex, Murray of Plymouth and Barnstable, Creem of Middlesex and Norfolk, Tolman of Middlesex and Suffolk and Hedlund of Plymouth and Norfolk.

Distinguished Guests.

The President introduced the Austin Prep Football Team. The team is the Division VI Super Bowl Champions and was accompanied by Coach Bill Maradei and Assistant Coach Reggie Lanciani. They were the guests of Senator Birmingham.

Petitions.

Petitions were presented and referred, as follows:

By Mr. Shannon (by request), a petition (subject to Joint Rule 12) of Kevin Hall for legislation to reduce the psychotropic drugging of school children; and

Report of a Committee.

By Mr. Jajuga, for the committee on Ways and Means, that the Senate Bill relative to the Massachusetts Water Resources Authority bond cap (Senate, No. 1056),— ought to pass, with an amendment, inserting before the enacting clause the following emergency preamble:

"Whereas, The deferred operation of this act would tend to defeat its purpose, which is forthwith to increase the Massachusetts Water Resources Authority bond limit in order to avoid disruption of ongoing projects, therefore, it is hereby declared to be an emergency law, necessary for the immediate preservation of the public health and convenience."

There being no objection, the rules were suspended, on motion of Ms. Melconian, and the bill was read a second time and was amended, as recommended by the committee on Ways and Means. The bill, as amended, was then ordered to a third reading, read a third time and passed to be engrossed, in concurrence, with the amendment.

Sent to the House for concurrence in the amendment.

PAPERS FROM THE HOUSE.

A Bill authorizing the town of Shirley to release a certain conservation restriction (House, No. 4929,— on petition) [Local approval received],— was read.

There being no objection, the rules were suspended, on motion of Ms. Resor, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.
