Report.

A report of the Attorney General (under the provisions of Section 99, Subsection R, of Chapter 272 of the General Laws) relative to warrants sought for wire and oral communications (received Tuesday, February 8, 2000),— was read and sent to the House for its information.

The House Bill relative to foothold traps and certain other devices (House, No. 4884),—was considered, the main question being on ordering it to a third reading.

Mr. Pacheco offered an amendment, striking out all after the enacting clause and inserting in place thereof the text of Senate document numbered 2094; and by inserting before the enacting clause the following emergency preamble:—
"Whereas, The deferred operation of this act would tend to defeat its purpose, which is forthwith to protect persons from threats to human health and safety caused by certain animals, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public health, safety and convenience."; and this amendment was adopted.

The bill, as amended, was then ordered to a third reading.

Subsequently, there being no objection, the rules were suspended, on motion of Mr. Pacheco, and the bill was read a third time and, after debate, was passed to be engrossed, in concurrence.

Sent to the House for concurrence in the amendment.

PAPERS FROM THE HOUSE.

Engrossed bills.

Emergency Preamble Adopted.

An engrossed Bill relative to the terms of certain bonds and notes issued by the Commonwealth (see House Bill, printed in House No. 4938), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,— was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted, in concurrence, by a vote of 7 to 0. The bill was signed by the President and sent to the House for enactment.

A Bill relative to representative town meetings in the town of Braintree (House, No. 4859, changed,— on petition) [Local approval received],— was read.

There being no objection, the rules were suspended, on motion of Mr. Rosenberg, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.

A Bill authorizing the town of Braintree to convey certain easements (House, No. 4860,— on petition) [Local approval received],— was read.

There being no objection, the rules were suspended, on motion of Ms. Melconian, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.

Order Adopted.

On motion of Ms. Melconian,-

Ordered, That when the Senate adjourns today, it adjourn to meet again on Thursday next at eleven o'clock A.M., and that the Clerk be directed to dispense with the printing of a calendar.

Adjournment in memory of Shirley Palmer.

Mr. Nuciforo moved that when the Senate adjourns today, it adjourn in memory of five-year old Shirley Palmer, who lost her life in the Housatonic River in Great Barrington on January 25, 2000. She will be greatly missed by all those who knew her but will live on in their hearts and the hearts of all who helped search for her. This motion prevailed.
