# Emergency Preamble Adopted; Engrossed Bill Enacted.

An engrossed Bill relative to the trustees of the University of Massachusetts (see Senate, No. 1753), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,— was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted, in concurrence, by a vote of 2 to 0.

The bill was signed by the President and sent to the House for enactment.

Subsequently, the bill, which originated in the Senate, came from the House with the endorsement that it had been enacted in that branch.

The Senate then passed the bill to be enacted; and it was signed by the President and laid before the Governor for his approbation.

# Engrossed Bill.

An engrossed Bill authorizing consideration of a certain ballot question at the April 26, 1999 annual election in the town of Ashby (see House Bill, printed in House, No. 4226) (which originated in the House), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, was passed to be enacted, two-thirds of the members present having voted in the affirmative, and it was signed by the President and laid before the Governor for his approbation.
