Matter Taken Out of the Orders of the Day.

There being no objection, the following matter was taken out of the Orders of the Day and considered, as follows: The House Bill authorizing the town of Hopkinton to establish an open space preservation fund (House, No. 481),— was read a second time.

Pending the question on ordering to a third reading, an amendment, presented by Mr. Magnani, in section 7, by inserting after the first sentence the following two sentences:— "The commission may shorten or waive the advertising requirements of section 16B of chapter 30B of the General Laws if the commission determines in writing that advertising will not benefit the commission's interest because of the unique qualities or location of the property. The commission shall comply with all other requirements of said chapter 30B for the acquisition of an interest in real property."; in section 8, by inserting after the word "otherwise", in line 5, the following words:— "pursuant to the procedures set forth in section 16 of chapter 30B of the General Laws"; and in section 12, by striking out the last sentence and inserting in place thereof the following sentence:— "An acceptable bid shall be an amount deemed sufficient by the town but in no event shall be less than the amount owed to the town to redeem the title.",— was considered; and it was adopted.

The bill, as amended, was then ordered to a third reading.

The bill was then read a third time and passed to be engrossed, in concurrence, with the amendment. Sent to the House for concurrence in the amendment.

PAPER FROM THE HOUSE.

A Bill relative to the Onset Fire District (House, No. 2561,— on petition),— was read.

There being no objection, the rules were suspended, on motion of Ms. Creem, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.
