Met at seven minutes past eleven o'clock A.M. (Mr. Rosenberg in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

Reports.

The following reports were severally read and placed on file:

A report of the Public Employee Retirement Administration Commission (under the provisions of Section 50 of Chapter 7 of the General Laws) submitting rules and regulations governing retirement of public employees in Massachusetts (received Wednesday, June 28, 2000); and

A report of the Executive Office for Administration and Finance (under the provisions of Section 4 of Chapter 280 of the Acts of 1998) submitting the results of a study on women and construction projects (received Thursday, June 29, 2000).

A report of the Bureau of Special Investigations (under the provisions of Section 15D(6) of Chapter 22 of the General Laws) submitting its report for the month of May, 2000 (received Wednesday, June 28, 2000),— was read and sent to the House for its information.

Engrossed Bill.

An engrossed Bill validating the actions taken at the 2000 annual town election of the town of Tyngsborough (see House Bill, printed in House, No. 5301) (which originated in the House), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, was passed to be enacted, two-thirds of the members present having voted in the affirmative, and it was signed by the Acting President and laid before the Governor for his approbation.
