## PAPERS FROM THE HOUSE.

Bi-monthly reports (for January, 1999; May, 1999; July, 1999; September, 1999; and November, 1999) of the Massachusetts Turnpike Authority (under Section 178 of Chapter 653 of the Acts of 1989) submitting accounts of the costs incurred in connection with the depression of the Central Artery and the construction of the Ted Williams Tunnel (having been sent by the House to the Senate for its information),—were returned to the House to be placed on file.

Authorizing the town of Dennis to deposit certain funds into its capital improvement fund (House, No. 5171,— on petition) [Local approval received];

Relative to the historic district committee for the town of Dennis (House, No. 5173,— on petition) [Local approval received];

Relative to the board of cemetery commissioners of the town of Dennis (House, No. 5174,— on petition) [Local approval received];

Exempting certain positions in the town of Swampscott from the provisions of civil service law (House, No. 5226,— on petition) [Local approval received]; and

Authorizing the town of Walpole to issue two additional licenses for the sale of all alcoholic beverages to be drunk on the premises (House, No. 5251,— on petition) [Local approval received];

Were severally read and, under Senate Rule 26, placed in the Orders of the Day for the next session.

Matter Taken Out of the Orders of the Day.

There being no objection, the following matter was taken out of the Orders of the Day and considered, as follows:

The House Bill authorizing the town of Hull to increase the pension of firefighter John Clasby (House, No. 5205, amended), was read a third time.

Pending the question on passing the bill to be engrossed, Mr. Hedlund presented an amendment in section 1, by inserting after the word "firefighter", in line 9, the following words:— ", upon determination in accordance with the procedures and requirements of section 7 of chapter 32 of the General Laws that such member is unable to perform the essential duties of his job and that such inability is likely to be permanent and that he should be so retired."

The amendment was adopted.

The bill was then passed to be engrossed, in concurrence, with the amendment.
