#### Comunication.

A communication from Joseph E. Connarton, Executive Director, Public Employee Retirement Administration Commission, submitting a copy of its actuarial valuation report (received Monday, September 25, 2000),— was placed on file.

## Report.

## Committees Discharged.

# Order Adopted.

The following House Order (approved by the committees on Rules of the two branches, acting concurrently) was considered forthwith and adopted, in concurrence, to wit: *Ordered*, That, notwithstanding the provisions of Joint Rule 10, the committee on Public Service be granted until Friday, September 29, 2000, the time within which to make its final report on current House document numbered 5410.

# Engrossed Bills.

The following engrossed bills (both of which originated in the House), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, were severally passed to be enacted and were signed by the President and laid before the Governor for his approbation, to wit:

Establishing the Upper Cape regional water supply cooperative (see House, No. 4596, amended); and

Designating state highway route 213 in Methuen as the Loop Connector (see House, No. 5443, amended).

#### Matters Taken Out of the Orders of the Day.

There being no objection, the following matters were taken out of the Orders of the Day and considered, as follows:

The House Bill relative to zoning by-laws (House, No. 5217),—was read a second time.

Mr. Rosenberg presented an amendment, inserting before the enacting clause the following emergency preamble:—
"Whereas, The deferred operation of this act would tend to defeat its purpose, which is to provide forthwith an alternative procedure for the attorney general to review zoning by-laws, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience."

The amendment was adopted.

The bill, as amended, was then ordered to a third reading, read a third time and passed to be engrossed, in concurrence, with the amendment.

Sent to the House for concurrence in the amendment.

The House Bill authorizing a payment in lieu of taxes agreement between the town of Dracut and Nickel Hill Energy, LLC (House, No. 5283),— was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.

## Order Adopted.
