Met at one minute past eleven o'clock A.M. (Ms. Melconian in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

Distinguished Guest.

The Chair (Ms. Melconian) introduced, seated in the rear of the Chamber, Vivek Pandit of India. Mr. Pandit currently holds positions of Director, Samarthan and Trustee, Vidhayak Sansad. Mr. Pandit is here studying legislative procedure as an Eisenhower Fellow and was the guest of Senator Moore.

Communications.

A communication was received from the President concerning the Mass-Care and Massachusetts Law Reform Institute appointments to the advisory committee established (pursuant to section 32 of Chapter 141 of the Acts of 2000) relative to a consolidated system of health care financing. Barbara Waters Roop will be the representative from Mass-Care and Victoria Pulos, Esq., will be the representative of the Massachusetts Law Reform Institute.

A communication was received from the Minority Leader announcing the following appointment:
