Met at two minutes past eleven o'clock A.M. (Mr. Bernstein in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

Communications.

A communication was received from the President announcing the following appointments:

The Senator from Middlesex, Mr. Panagiotakos, and the Senator from Essex and Middlesex, Ms. Tucker, to the special commission established (pursuant to section 4A of chapter 193 of the Acts of 2000) relative to investigating the need for renovation and revitalization of state-assisted housing developments;

The Senator from Worcester and Middlesex, Mr. Antonioni, the Senator from Essex, Mr. Jajuga, the Senator from Plymouth and Barnstable, Ms. Murray, the Senator from Middlesex, Norfolk and Worcester, Mr. Magnani, and the Senator from Norfolk, Bristol and Plymouth, Mrs. Sprague, to the special commission established (pursuant to section 8 of chapter 227 of the Acts of 2000) relative to developing models of alternative education programs for disruptive students;

Emergency Preamble Adopted; Engrossed Bill Enacted.

An engrossed Bill relative to zoning by-laws (see House, No. 5217, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,— was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted, in concurrence, by a vote of 3 to 0.

The bill was signed by the Acting President and sent to the House for enactment.

Subsequently, the bill, which originated in the House, came from the House with the endorsement that it had been enacted in that breach

The Senate then passed the bill to be enacted; and it was signed by the Acting President and laid before the Governor for his approprobation.

Resolutions.

The Senate Bill making certain corrections to the regional tourism facilities board and administration of the urban renewal and revitalization program (Senate, No. 2288),— came from the House passed to be engrossed, in concurrence, with an amendment, striking out section 3.

The rules were suspended, on motion of Mr. Shannon, and the House amendment was considered forthwith and adopted, in concurrence.

House Order Adopted.

The following House Order (approved by the committees on Rules of the two branches, acting concurrently) was considered forthwith and adopted, in concurrence, to wit:

Ordered, That, notwithstanding the provisions of Joint Rule 10, the committee on Local Affairs be granted until Friday, October 27, 2000, the time within which to make its final report on House documents numbered 5165, 5384 and 5433, relative to the town of Cohasset and cities of Brockton and Lawrence.
