Met at two minutes past eleven o'clock A.M. (Ms. Melconian in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

Report.

A report of the Massachusetts State Lottery Commission (under the provisions of Section 24 of Chapter 10 of the General Laws) submitting its consolidated statement of operations for the lottery and arts lottery funds for the months of July and August, 1999 (received Monday, October 18, 1999),— was read and sent to the House for its information.

Petitions.

Petitions were presented and referred, as follows:

By Mr. Brewer, a petition (subject to Joint Rule 12) of Stephen M. Brewer, Stephen Kulik and Tracey Nowers for legislation to prohibit the sale of animals at flea markets; and

By Mr. Morrissey (by request), a petition (subject to Joint Rule 12) of Jan Heatley for legislation to allow equal access to public facilities to volunteer puppy raisers and certified trainers for Canine Companions for Independence;

Severally, under Senate Rule 20, to the committees on Rules of the two branches, acting concurrently.

PAPERS FROM THE HOUSE

Engrossed Bill.

An engrossed Bill relative to the election of members to the Pension Reserve Investment Board (see House, No. 113) (which originated in the House), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, was passed to be enacted and was signed by the Acting President and laid before the Governor for his approbation.

Matter Taken Out of the Orders of the Day.

There being no objection, the following matter was taken out of the Orders of the Day and considered, as follows: The Senate Bill authorizing the town of Ipswich to issue three additional licenses for the sale of all alcoholic beverages to be drunk on the premises (Senate, No. 1719),—was read third time.

An amendment, presented by Mr. Tarr, in section 1, by inserting after the figure "17", in line 7, the following words:— "and shall be transferable"; in section 2, by inserting after the figure "17", in line 8, the following words:— "and shall be transferable"; in section 3, by inserting after the figure "17", in line 8, the following words:— "and shall be transferable"; and by adding the following section:—

"SECTION 4. The issuance of the licenses authorized by this act shall increase by three the quota for permanent licenses that the town is authorized to issue for the sale of all alcoholic beverages.",— was considered; and it was adopted.

The bill (Senate, No. 2020, printed as amended), was then passed to be engrossed.

Senate Rule 36 was suspended, on motion of Ms. Fargo, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on State Administration.

On motion of Ms. Fargo, Senate Rule 20 and Joint Rule 12 were suspended on the petition, presented by Mr. Shannon (accompanied by bill) of Charles E. Shannon, J. James Marzilli, Jr., Anthony P. Giglio, Vincent P. Ciampa, Michael J. McGlynn and others (with the approval of the mayor and city council) for legislation relative to certain school construction projects in the city of Medford,— and the same was referred to the committee on Education, Arts and Humanities.

Sent to the House for concurrence.

PAPERS FROM THE HOUSE

A Bill authorizing the town of Charlton to issue three additional all alcoholic beverage licenses (House, No. 4471,— on petition) [Local approval received],— was read.

There being no objection, the rules were suspended, on motion of Mr. Lees, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence, its title having been changed by the

committee on Bills in the Third Reading to read as follows: "An Act authorizing the town of Charlton to issue three additional licenses for the sale of all alcoholic beverages not to be drunk on the premises."

Petitions were referred, in concurrence, as follows:

Petition (accompanied by bill, House, No. 4827) of Thomas N. George, Henri S. Rauschenbach, Shirley Gomes and Demetrius J. Atsalis for legislation to make certain changes in the office of Register of Deeds in Barnstable County;

Petition (accompanied by bill, House, No. 4828) of Stephen Kulik and Stanley C. Rosenberg that the Commissioner of the Department of Food and Agriculture be authorized to release certain land in the town of Whately from the operation of an agricultural preservation restriction;

Under suspension of Joint Rule 12, to the committee on State Administration.

A petition (accompanied by bill, House, No. 4829) of William Francis Galvin and Thomas M. Petrolati relative to making appropriations to fund certain collective bargaining agreements between the Secretary of the Commonwealth and the Register of Deeds in the Hampden and Southern Middlesex Districts and the Office and Professional Employees International Union Local 6 and the American Federation of State, County and Municipal Employees Union Local 414 Council 93,— came from the House referred, under suspension of Joint Rule 12 to the House committee on Ways and Means; and the Senate concurred in the suspension of said joint rule.
