### *Reports of a Committee.*

Mr. Brewer, for the committee on Steering and Policy, reported that the following matters be placed in the Orders of the Day for the next session:

The Senate Bill including a certain parcel of land in the town of Middleton in the South Essex sewage district (Senate, No. 2304); and

Relative to the procedures for junking motor vehicles (House, No. 150); and

Relative to the issuance of motor vehicle registration plates (House, No. 151).

### PAPERS FROM THE HOUSE.

A petition (accompanied by bill, House, No. 5479) of Peter J. Koutoujian and others (with the approval of the mayor and city council) relative to the eligibility to submit bids for certain school construction projects in the city of Waltham,— **was referred, in concurrence, to the committee on State Administration.**

A Bill authorizing the Division of Capital Asset Management and Maintenance to lease certain land to the town of Lancaster (House, No. 5463, amended,— on petition),— **was read and, under Senate Rule 27, referred to the committee on Ways and Means.**

Report of the University Counsel of Northeastern University (under the provisions of Section 2 of Chapter 645 of the Acts of 1986) relative to a summer boating program and a scholarship program established by said university under the terms of a lease of a certain parcel of land in the city of Boston; and

Semi-annual report of the Insurance Fraud Bureau (under the provisions of Section 99(k) of Chapter 398 of the Acts of 1991) on the disposition of matters referred to said bureau.

### ***Engrossed Bill.***

An engrossed Bill providing for a seasonal police force in the town of West Springfield (see House, No. 5436, amended) (which originated in the House), **having been certified by the Senate Clerk to be rightly and truly prepared for final passage, was passed to be enacted and was signed by the President and laid before the Governor for his approbation.**

### ***Order Adopted.***

The following House Order (approved by the committees on Rules of the two branches, acting concurrently) was considered forthwith and adopted, in concurrence, to wit:

*Ordered*, That, notwithstanding the provisions of Joint Rule 10, the committee on Local Affairs be granted until Thursday, November 30, 2000, the time within which to make its final report on current Senate document numbered 2301, relative to the establishment of a special fund in the town of Milton.

### ***Petition.***
