Met at three minutes past eleven o'clock A.M.

Petitions.

Mr. Magnani presented a petition (accompanied by bill, Senate, No. 2144) of David P. Magnani and Paul J. P. Loscocco (by vote of the town) for legislation relative to the town of Holliston and the establishment of a cemetery care fund [Local approval received],— **and the same was referred, under Senate Rule 20, to the committee on Local Affairs.**

Sent to the House for concurrence.

Mr. Pacheco presented a petition (subject to Joint Rule 12) of Marc R. Pacheco, Thomas J. O'Brien and William M. Straus for legislation to allow the Department of Highways to construct, expend or implement any project or road widening at the intersection of South Main Street and Route 28 in Middleborough,— **and the same was referred, under Senate Rule 20, to the committees on Rules of the two branches, acting concurrently.**

Committees Discharged.

Ms. Menard, for the committees on Rules of the two branches, acting concurrently, reported, asking to be discharged from further consideration of the Senate Order relative to authorizing the joint committee on Public Safety to make an investigation and study of certain current Senate documents relative to miscellaneous public safety issues (Senate, No. 2143),— and recommending that the same be referred to the Senate committee on Rules.

Under Senate Rule 36, the report was considered forthwith and accepted.

PAPER FROM THE HOUSE.

A Bill authorizing certain terms for borrowing by the town of Norfolk for constructing a golf course (House, No. 4423,— on petition) [Local approval received],— **was read and, under Senate Rule 26, placed in the Orders of the Day for the next session.**

Report of a Committee.

By Mr. Pacheco, for the committee on Natural Resources and Agriculture, on petition, a Bill authorizing the town of Stoughton to join the Massachusetts Water Resources Authority (Senate, No. 2086, changed in Section 1, in line 3, by striking out the words “ ‘Arlington’, in line 3” and inserting in place thereof the following words:—“ ‘Stoneham’, in line 9”) [Local approval received]. **The bill was read. The rules were suspended, on motion of Mr. Knapik, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, its title having been changed by the committee on Bills in the Third Reading to read as follows: “An Act requiring the Massachusetts Water Resources Authority to provide water to the town of Stoughton.”**

Reports of Committees.

By Ms. Menard, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of Frederick E. Berry for legislation relative to imposing punishment for those instances of controlled substance distribution where death results.

Senate Rule 36 was suspended, on motion of Mr. Tolman, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Criminal Justice.

By Ms. Menard, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of Cynthia S. Creem, Frank I. Smizik and Gregory L. Holmes, M.D. for legislation to establish and encourage donations to the Massachusetts Epilepsy Research Fund.

Senate Rule 36 was suspended, on motion of Mr. Tolman, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Taxation.

By Ms. Menard, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of Robert E. Travaglini, Edward J. Clancy, Jr., Anthony Petruccelli and Salvatore F. DiMasi for legislation to clarify the tax status of pilot boats, so-called.

Senate Rule 36 was suspended, on motion of Mr. Tolman, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Taxation.

Severally sent to the House for concurrence.

Matter Taken Out of the Orders of the Day.

There being no objection, the following matter was taken out of the Orders of the Day and considered, as follows:

The House Bill relative to a certain alcoholic beverage license in the town of Westborough (House, No. 4143),— **was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.**

PAPERS FROM THE HOUSE.

A Bill relative to the creation of a Belmont senior center furnishings and accessories fund (House, No. 4206,— on petition) [Local approval received],— was read.

There being no objection, the rules were suspended, on motion of Mr. Tolman, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence, its title having been changed by the committee on Bills in the Third Reading to read as follows: “An Act authorizing the town of Belmont to establish a senior center furnishings and accessories and operations fund.”

Engrossed Bill.

An engrossed Bill relative to voting precincts in the town of Ludlow (see House Bill, printed in House, No. 4518, changed) (which originated in the House), **having been certified by the Senate Clerk to be rightly and truly prepared for final passage, was passed to be enacted, two-thirds of the members present having voted in the affirmative, and it was signed by the President and laid before the Acting Governor for her approbation.**
