#### PAPER FROM THE HOUSE.

The House Order relative to the appointment of a joint special committee to make an investigation and study of the Joint Rules of the two branches of the General Court (House, No. 2824),—was considered.

Ms. Menard presented the following amendment; striking out, in line 2, the word "four" and inserting in place thereof the following word:— "seven"; inserting after the word "them", in line 11, the following words:— "including matters referred after the initial period"; and inserting after the word "legislation", in line 12, the following words:— "and the procedure for filing legislation after the required time; amending Joint Rule 12A to allow additional formal sessions for limited purposes including overriding vetoes".

The amendments were adopted.

The order (House, No. 2824), as amended, was then adopted.
