Monday, March 25, 2002.

Met at five minutes past eleven o'clock A.M. (Ms. Melconian in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

#### Petitions.

Petitions were presented and referred, as follows:

By Mr. Glodis, a petition (subject to Joint Rule 12) of Guy W. Glodis and John P. Fresolo for legislation to allow the state Board of Retirement to grant Sandra Pigaga creditable service for the purpose of determining a retirement allowance; and

By Mr. Nuciforo, a petition (subject to Joint Rule 12) of Andrea F. Nuciforo, Jr., Daniel E. Bosley and Shaun P. Kelly for legislation relative to establishing the Berkshire County Regional Housing Authority;

Severally, under Senate Rule 20, to the committees on Rules of the two branches, acting concurrently.

By Mr. Montigny, for the committee on Ways and Means, that the Senate Bill relative to street lists (Senate, No. 2084),—ought to pass.

By Mr. Montigny, for the committee on Ways and Means, that the House Bill relative to handicapped stickers for motorcycle license plates (House, No. 4099) — ought to pass, with amendments, striking out all after the enacting clause and inserting in place thereof the text of Senate document numbered 2293; and by inserting before the enacting clause the following emergency preamble:—

"Whereas, The deferred operation of this act would tend to defeat its purpose, which is forthwith to extend handicap access rights to persons owning motorcycles, therefore, it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience."

There being no objection, the rules were suspended, on motion of Ms. Chandler, and the bill was read a second time and was amended, as recommended by the committee on Ways and Means. The bill, as amended, was then ordered to a third reading.

By Mr. Montigny, for the committee on Ways and Means, that the House Bill relative to veteran registration plates for motorcycles (House, No. 4334) — ought to pass, with amendments, striking out all after the enacting clause and inserting in place thereof the text of Senate document numbered 2294; and by inserting before the enacting clause the following emergency preamble:—

"Whereas, The deferred operation of this act would tend to defeat its purpose, which is forthwith to extend the right to display certain 'veteran' registration plates and emblems to qualified owners of motorcycles, therefore, it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience."

There being no objection, the rules were suspended, on motion of Mr. Baddour, and the bill was read a second time and was amended, as recommended by the committee on Ways and Means. The bill, as amended, was then ordered to a third reading.

Matter Taken Out of the Orders of the Day.

There being no objection, the following matter was taken out of the Orders of the Day and considered as follows:

The Senate report of the committee on Counties, ought NOT to pass (under Joint Rule 10), on the petition (accompanied by bill, Senate, No. 438) of Andrea F. Nuciforo, Jr. and Daniel E. Bosley for legislation relative to the fee charged for a license of a specially trained dog for disabled persons,— was considered, the question being on accepting the adverse report.

On motion of Mr. Rosenberg, the petition was recommitted to the committee on Counties.

PAPERS FROM THE HOUSE.

A Bill establishing a special police force in the town of Agawam (House, No. 4190,— on petition) [Local approval received],— was read.

There being no objection, the rules were suspended, on motion of Ms. Chandler, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence, its title having been changed by the committee on Bills in the Third Reading to read as follows: "An Act establishing a special police force in the city known as the town of Agawam".
