Petitions.

Mr. Rosenberg presented a petition (accompanied by bill, Senate, No. 1855) of Stanley C. Rosenberg and Ellen Story (by vote of the town) for legislation relative to the Amherst town charter [Local approval received],— **and the same was referred, under Senate Rule 20, to the committee on Local Affairs.**

Sent to the House for concurrence.

Mr. Tolman presented a petition (subject to Joint Rule 12) of Steven A. Tolman and Rachel Kaprielian for legislation relative to continued taxability of real property purchased by charitable organizations,— **and the same was referred, under Senate Rule 20, to the committees on Rules of the two branches, acting concurrently.**
