### *Communication.*

A communication was received from Senator Stephen F. Lynch in compliance with Massachusetts General Laws Chapter 268A (received May 11, 2001).

**The communication was placed on file.**

### *Petition.*

Mr. Nuciforo presented a petition (subject to Joint Rule 12) of Andrea F. Nuciforo, Jr., and Shaun P. Kelly for legislation to authorize the Division of Fisheries and Wildlife to take or acquire conservation restrictions in and to lands of the Dalton Fire District,— **and the same was referred, under Senate Rule 20, to the committees on Rules of the two branches, acting concurrently.**

Petition (accompanied by bill, House, No. 4147) of Shirley Gomes and Robert A. O'Leary (by vote of the town) relative to betterment assessments in the town of Provincetown;  
**To the committee on Taxation.**

A report of the committee on Public Service, asking to be discharged from further consideration of the petition (accompanied by bill, House, No. 4131) of Paul Kujawski, David L. Flynn and Guy W. #### *Report of Committees.*

By Ms. Menard, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of Jeffrey Mankiewicz for legislation to regulate the medical treatment of chronic intractable pain.

**Senate Rule 36 was suspended, on motion of Ms. Fargo, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Health Care.**

#### *Matters Taken Out of the Orders of the Day.*

There being no objection, the following matters were taken out of the Orders of the Day and considered, as follows:

The Senate report of the committee on Public Safety, ought NOT to pass, on the petition (accompanied by bill, Senate, No. 1167) of Cynthia S. Creem, Cheryl A. Jacques, Bruce E. Tarr, Carol A. Donovan and Mary Jane Simmons for legislation to require the

tagging of explosive materials,— was considered, the question being on accepting the adverse report.

**There being no objection, on motion of Ms. Fargo, the petition was recommitted to the committee on Public Safety.**

The Senate report of the committee on Public Safety, ought NOT to pass, on the petition (accompanied by bill, Senate, No. 1175) of Nico Lang for legislation to authorize and direct the Registry of Motor Vehicles to grant handicap license plates and place cards to persons diagnosed with Acromesamilik Skeletal Dysplasia,— was considered, the question being on accepting the adverse report.

**There being no objection, on motion of Mr. Brewer, the petition was recommitted to the committee on Public Safety.**

The Senate Bill relative to residency requirements for fortune teller's license (Senate, No. 443),— **was read a second time, ordered to a third reading, read a third time and passed to be engrossed, its title having been changed by the committee on Bills in the Third Reading to read as follows: "An Act removing residency requirements for a fortune teller's license".**

**Sent to the House for concurrence.**
