Met at seven minutes past eleven o'clock A.M.

Distinguished Guests.

There being no objection, the President introduced, seated in the rear of the Chamber, members of the Agawam High School Model Congress and Advanced Placement studies group. The group was accompanied by members of the Agawam Democratic Town Committee and they were the guests of Senator Melconian.

Petitions.

Petitions were presented and referred, as follows:

By Ms. Menard, a petition (subject to Joint Rule 12) of Joan M. Menard and Patricia A. Haddad for legislation relative to the retirement benefits of Steven Moniz; and

By Mr. Tolman, a petition (subject to Joint Rule 12) of Steven A. Tolman and Rachel Kaprielian (with the approval of the town council) for legislation to provide for the continued taxability of certain real and personal property located in the town of Watertown [Local approval received];

Severally, under Senate Rule 20, to the committees on Rules of the two branches, acting concurrently.

Reports of a Committee.

By Mr. Panagiotakos, for the committee on Housing and Urban Development, on petition, a Bill authorizing the Metropolitan District Commission to construct certain flood control facilities in the Beaver Brook section of Lexington, Arlington, Belmont and Waltham (printed as House, No. 823);

By Mr. Panagiotakos, for the committee on Housing and Urban Development, on petition, a Bill designating a walking path at Squantum Point Park as the Janet Niles Murphy Walkway (Senate, No. 627); and

By the same Senator, for the same committee, on petition (accompanied by bill, House, No. 3107), a Bill relative to condominium by-laws (Senate, No. 1877);

Severally read and, under Senate Rule 26, referred to the committee on Steering and Policy.

The Senate Bill validating all actions taken at the annual town meeting election of the town of Longmeadow on May 23, 2000 (Senate, No. 1817),— **was read a second time, ordered to a third reading, read a third time and passed to be engrossed, its title having been changed by the committee on Bills in the Third Reading to read as follows: "An Act validating actions taken at the annual town election of the town of Longmeadow on May 23, 2000".**

Senate Rule 36 was suspended, on motion of Ms. Murray, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Public Safety.
