Engrossed Bill — Laid Before the Acting Governor.

An engrossed Bill relative to simulcast wagering of horse and dog racing (see House, No. 4265, amended) (which originated in the House), **having been passed to be enacted and signed by the Acting President (Mr. Creedon) on Wednesday, June 27, 2001,— was laid before the Acting Governor on Thursday, June 28, 2001, for her approbation.**
