Met at two minutes past eleven o'clock A.M.

Communication.

A communication was received from the President announcing the following appointments:

The Senator from Middlesex, Mr. Panagiotakos, the Senator from Suffolk, Ms. Wilkerson, the Senator from Bristol, Ms. Menard, the Senator from Essex and Middlesex, Ms. Tucker, and the Senator from Middlesex, Mr. Tisei, to the special commission established (pursuant to section 4A of Chapter 97 of the Acts of 2002) relative to state assisted family public housing in the Commonwealth;

House Order — Amended.

The House Order relative to extending until Tuesday, December 31, 2002, the time within which joint standing committees and the committees on Rules of the two branches, acting concurrently be granted to make reports on all matters referred to them, which had been previously amended by the Senate by striking out the words "Tuesday, December 31" and inserting in place thereof the words "Monday, September 30", came from the House with the endorsement that the House concurred with the Senate in its amendment with a further amendment, striking out the words "Monday, September 30" and inserting in place thereof the words "Thursday, October 31".

The rules were suspended, on motion of Mr. Moore and the further House amendment was considered forthwith. Pending the question on adoption of the further House amendment, Ms. Menard presented a still further amendment by striking out the words "Thursday, October 31, 2002" and inserting in place thereof the words "Monday, November 4, 2002".

The still further amendment was adopted.

The further House amendment, as amended, was then adopted.

Sent to the House for concurrence in the still further amendment.
