Engrossed Bill.

Adjournment in Memory of Peter J. Murphy.

Ms. Chandler presented a request that when the Senate adjourns today, it adjourn in memory of Peter J. Murphy of Lakewood, Colorado. Peter J. Murphy, a long-time resident of Amherst and Worcester, Massachusetts died suddenly Tuesday evening October 22. Mr. Murphy was an expert in fluid dynamics and worked as a consultant and expert witness on numerous cases, including the ground water contamination cases in Woburn, which were the subject of a book and movie entitled "A Civil Action".
