Engrossed Bill.

An engrossed Bill providing for the annual observance of myositis awareness day (see House, No. 3970) (which originated in the House), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, was passed to be enacted and was signed by the Acting President and laid before the Governor for his approbation.
